

ORDINANCE NO. JO-104-2020

A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND THE LAFAYETTE PARISH COUNCIL AUTHORIZING THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT TO SELL AT PUBLIC AUCTION SURPLUS VEHICLES, EQUIPMENT AND OTHER MISCELLANEOUS MOVEABLE PROPERTY WHICH ARE NO LONGER NEEDED FOR PUBLIC PURPOSES, AS PER THE ATTACHED LIST (AUCTION)

BE IT ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

SECTION 1: The Lafayette City-Parish Consolidated Government (“LCG”) has in storage, surplus vehicles, equipment and other miscellaneous LCG moveable property, which is no longer needed for public purposes, as per the attached list.

SECTION 2: It would be in the best interest of the Lafayette City-Parish Consolidated Government to sell this moveable property at a public auction to the highest bidder.

SECTION 3: The attached list represents the surplus LCG moveable property to be sold.

SECTION 4: All items shall be sold in an “as-is, where-is” condition. The Lafayette City-Parish Consolidated Government reserves the right to reject any or all bids, establish minimum bid prices, or withdraw any items from the sale.

SECTION 5: The Lafayette Mayor-President, Joshua S. Guillory, be and he is hereby authorized and directed to sell at a public auction surplus LCG moveable property as per the attached list.

SECTION 6: It is specifically recognized that all requirements of the State law pertaining to the sale of surplus moveable property including notice of this proposed ordinance to the public shall be adhered to.

SECTION 7: Any opposition to this ordinance shall be made in writing and filed with the Office of the Clerk of the Council within 15 days of first publication.

SECTION 8: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 9: EFFECTIVE DATE. After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.




