#### **ORDINANCE NO. JO-040-2021**

A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND THE LAFAYETTE PARISH COUNCIL AMENDING THE FY 20/21 OPERATING BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY AUTHORIZING THE TRANSFER OF \$90,000 IN COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS WITHIN THE COMMUNITY DEVELOPMENT DEPARTMENT TO THE HUB LAFAYETTE URBAN MINISTRIES

**BE IT ORDAINED** by the Lafayette City Council and the Lafayette Parish Council, that:

SECTION 1: The FY 20/21 operating budget of the Lafayette City-Parish Consolidated Government is hereby amended by transferring \$90,000 in CDBG funds within the Community Development Department to The Hub Lafayette Urban Ministries. Funds will be used for the acquisition of a vacant building located at 1515 West University Avenue to be used to host The Lovewell Center, which will provide education and non-housing services to homeless individuals in Lafayette.

**SECTION 2:** The transfer of funds shall be contingent upon completion of an environmental review and the finding of no significant impact as reached in accordance with HUD environmental review regulations.

SECTION 3: The Hub Lafayette Urban Ministries is required to follow all federal CDBG guidelines as required by HUD in 24 CFR 570, including 24 CFR 570.201(a) for the acquisition of real property funded with CDBG. For five (5) years after The Lovewell Center opens, the use of the property may not change from its originally-intended purpose, and its intended beneficiaries may not change.

**SECTION 4:** The Lafayette City Council and the Lafayette Parish Council do hereby authorize the Lafayette Mayor-President, or his designee, to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, payment requests, memoranda of understanding and so on, which may be necessary for the completion of the aforementioned project.

**SECTION 5:** This transfer of funds shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

**SECTION 6:** All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 7: After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-

President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.  *****
