AN ORDINANCE OF THE LAFAYETTE CITY COUNCIL AMENDING THE FY 20/21 OPERATING BUDGET AND CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY TRANSFERRING \$58,000.00 FROM UNEXPENDED/UNENCUMBERED SALARIES IN DIVISION 5134 AND \$188,171.01 IN EXCESS FUNDS FROM THE POLLY LANE EXTENSION PROJECT AND APPROPRIATING WITHIN THE PUBLIC WORKS DEPARTMENT, CAPITAL IMPROVEMENTS DIVISION FOR THE AMBASSADOR CAFFERY SOUNDWALL PROJECT

BE IT ORDAINED by the Lafayette City Council, that:

SECTION 1: The FY 20/21 operating budget and capital budget of the Lafayette City-Parish Consolidated Government is hereby amended by transferring \$58,000.00 from unexpended/unencumbered salaries within division 5134 and \$188,171.01 in excess funds from the Polly Lane Extension Project and appropriating within the Public Works Department, Capital Improvements Division for the Ambassador Caffery Soundwall RPL/RPR Project (\$246,171.01).

SECTION 2: This transfer of funds shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

SECTION 3: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.
