## PARISH ORDINANCE NO. PO-067-2021

AN ORDINANCE OF THE LAFAYETTE PARISH COUNCIL AMENDING THE FY 21/22 OPERATING AND CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY INCREASING THE USE OF PRIOR YEAR FUND BALANCE IN FUND 264 COURTHOUSE COMPLEX FUND IN THE AMOUNT OF \$750,000 AND APPROPRIATING WITHIN FUND 262 CORRECTIONAL CENTER FUND FOR THE PURCHASE OF LAND FOR A NEW PARISH JAIL

BE IT ORDAINED by the Lafayette Parish Council, that:

SECTION 1: The FY 21/22 operating and capital budget of the Lafayette City-Parish Consolidated Government is hereby amended by increasing the use of prior year fund balance in Fund 264 Courthouse Complex Fund in the amount of \$750,000 and appropriating within Fund 262 Correctional Center Fund for the purchase of land for a new Parish jail.

SECTION 2: This transfer of funds shall be reflected in any pertinent documents which are attached and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

**SECTION 3**: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.
