ORDINANCE NO. JO-079-2021

A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND THE LAFAYETTE PARISH COUNCIL AMENDING CHAPTER 86, "TRAFFIC AND VEHICLES," OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT CODE OF ORDINANCES TO ADD ARTICLE XI, "LAFAYETTE TRANSIT SYSTEM"

BE IT ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

WHEREAS, the Lafayette City-Parish Consolidated Government maintains a public transportation system within the City of Lafayette; and

WHEREAS, Ordinance No. O-169-2008 presently sets forth the public transportation services provided by the Lafayette Transit System and fares charged for such services; and

WHEREAS, the Lafayette City Council and the Lafayette Parish Council desire to amend and enact certain public transportation services and fares; and

WHEREAS, in addition, the Lafayette City Council and the Lafayette Parish Council desires to include this information in the Lafayette City-Parish Consolidated Government Code of Ordinances by amending Chapter 86 of the Lafayette City-Parish Consolidated Government Code of Ordinances to include a section regarding the Lafayette Transit System; and

WHEREAS, also, under the section pertaining to the Lafayette Transit System the Lafayette City Council and the Lafayette Parish Council desire to add a section concerning transit shelter advertising.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

SECTION 1: All of the aforedescribed "Whereas" clauses are hereby adopted as part of this ordinance.

SECTION 2: The Lafayette City-Parish Consolidated Government Code of Ordinances, Chapter 86, is hereby amended by adding and enacting Article XI. "Lafayette Transit System," Section 86-200, "Services and Fares," which shall read as follows:

SECTION 3: The Lafayette City-Parish Consolidated Government Code of Ordinances, Chapter 86, is hereby amended by adding and enacting Article XI. "Lafayette Transit System," Section 86-201, "Transit Shelter Advertising," which shall read as follows:

The Director has the authority to issue monthly permits for advertising space on LTS transit shelters in accordance with the following schedule. The Director is authorized to vary advertising rates based on demand, location and/or time of year; provided, however that the rates are within the amounts set forth in the table below. The Director is also authorized to bill monthly any person or organization for the advertising space. The Director is further authorized to set the regulations and payment methods for such permits.

Monthly Rate per Shelter Advertising Panel	
\$200 - \$600*	

*In the event an agreement is executed with a third party to manage advertisements on the LTS transit shelters, the foregoing rates shall not apply. The rates for shelter advertisement shall be determined and regulated in accordance with the terms of the agreement executed with the third party to manage the LTS transit shelter advertisement.

SECTION 4: Amendments to the Lafayette City-Parish Consolidated Government Code of Ordinances, Chapter 86, Traffic and Vehicles, Ordinance No. O-169-2008 shall be reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

SECTION 5: All ordinances and resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 6: After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.
