## ORDINANCE NO. JO-014-2022

A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND THE LAFAYETTE PARISH COUNCIL AMENDING THE FY 21/22 OPERATING BUDGET AND ADJUSTING MANNING TABLES OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY AUTHORIZING THE USE OF PY FUND BALANCE OF THE CITY GENERAL FUND (FUND 101) IN THE AMOUNT OF \$104,072 AND APPROPRIATING WITHIN THE DEPARTMENT OF COMMUNITY DEVELOPMENT & PLANNING, COMPLIANCE DIVISION

**BE IT ORDAINED** by the Lafayette City Council and the Lafayette Parish Council, that:

SECTION 1: The FY21/22 operating budget of the Lafayette City-Parish Consolidated Government is hereby amended by authorizing the use of PY Fund Balance of the City General Fund (Fund 101) in the amount of \$104,072 and appropriating within the Community Development & Planning Department's Compliance Division to fund expenses related to the operations of the division, including necessary staffing for the division.


SECTION 2: The FY21/22 manning tables of the Lafayette City-Parish Consolidated Government are hereby adjusted by adding one (1) Compliance Manager position, one (1) Compliance Inspector position and transferring one (1) Clerk III position from the Development Division to the Compliance Division of the Department of Community Development & Planning.

SECTION 3: These transfers of funds shall be reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

**SECTION 4:** All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 5: After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.
