#### ORDINANCE NO. JO-021-2022

A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND THE LAFAYETTE PARISH COUNCIL AMENDING THE LAFAYETTE DEVELOPMENT CODE (LDC), CHAPTER 89 OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT CODE OF ORDINANCES

BE IT ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

WHEREAS, on December 16, 2020, by Joint Ordinance No. JO-111-2020, the Lafayette City Council and the Lafayette Parish Council adopted Chapter 89 of the Lafayette City-Parish Code of Ordinances, including Appendix A, the "Lafayette Development Code" ("LDC"); and

WHEREAS, on June 15, 2021, by Joint Ordinance No. JO-024-2021, the Lafayette City Council and Lafayette Parish Council amended the LDC; and

WHEREAS, since its adoption, the LDC has played an essential role in the implementation of the comprehensive master plan for the City of Lafayette and unincorporated Parish of Lafayette; and

WHEREAS, in their January and February 2022 meetings, the Lafayette City and Lafayette Parish Planning Commissions and the Lafayette City Zoning Commission voted to recommend that amendments to the LDC be adopted by the Lafayette City Council and the Lafayette Parish Council, with said reports containing the Commissions' recommendations being attached hereto and made a part of hereof as Exhibit A; and

WHEREAS, consistent with the comprehensive master plan for the City of Lafayette and unincorporated Parish of Lafayette, the Lafayette City Council and Lafayette Parish Council desire to amend the LDC in several respects, all as more fully detailed herein, the same being done in furtherance of the health, safety and welfare of the citizens of the City of Lafayette and unincorporated Parish of Lafayette.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

**SECTION 1:** All of the aforedescribed "Whereas" clauses are adopted as part of this ordinance.

**SECTION 2:** Article 2 of the Lafayette Development Code ("LDC") is hereby amended, as specifically set forth in **Exhibit B** (redline and clean) attached hereto and made a part hereof.

SECTION 3: Article 3 of the Lafayette Development Code ("LDC") is hereby amended, as specifically set forth in <a href="Exhibit C">Exhibit C</a> (redline and clean) attached hereto and made a part hereof.

**SECTION 4:** Article 4 of the Lafayette Development Code ("LDC") is hereby amended, as specifically set forth in **Exhibit D** (redline and clean) attached hereto and made a part hereof.

**SECTION 5:** Article 5 of the Lafayette Development Code ("LDC") is hereby amended, as specifically set forth in **Exhibit E** (redline and clean) attached hereto and made a part hereof.

**SECTION 6:** Article 6 of the Lafayette Development Code ("LDC") is hereby amended, as specifically set forth in **Exhibit F** (redline and clean) attached hereto and made a part hereof.

**SECTION 7:** Article 8 of the Lafayette Development Code ("LDC") is hereby amended, as specifically set forth in **Exhibit G** (redline and clean) attached hereto and made a part hereof.

**SECTION 8:** Article 10 of the Lafayette Development Code ("LDC") is hereby amended, as specifically set forth in **Exhibit H** (redline and clean) attached hereto and made a part hereof.

**SECTION 9:** Appendix A of the Lafayette Development Code ("LDC") is hereby amended, as specifically set forth in **Exhibit I** (redline and clean) attached hereto and made a part hereof.

**SECTION 10:** All ordinances or resolutions, or parts thereof, in conflict herewith, including but not limited to Ordinance No. JO-111-2020 and Ordinance No. JO-024-2021, are hereby repealed.

**SECTION 11:** After first having been adopted by a majority of the authorized membership of both the Lafayette City Council and the Lafayette Parish Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.
