

PARISH ORDINANCE NO. PO-012-2022

AN ORDINANCE OF THE LAFAYETTE PARISH COUNCIL AMENDING THE FY 21/22 CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY INCREASING REIMBURSEMENT REVENUES FROM STATE OF LOUISIANA FACILITY PLANNING AND CONTROL FOR GOVERNMENT COMPLEX, RENOVATIONS OF PARISH COURTHOUSE, PROJECT NO. 50-J28-04B-03 IN THE AMOUNT OF \$4,500,000 TO BE APPROPRIATED WITHIN THE PUBLIC WORKS DEPARTMENT FOR SAID PROJECT

BE IT ORDAINED by the Lafayette Parish Council, that:

SECTION 1: The FY 21/22 capital budget of the Lafayette City-Parish Consolidated Government is hereby amended by increasing reimbursement revenues from State of Louisiana Facility Planning and Control for Government Complex, Renovations of Parish Courthouse, Project No. 50-J28-04B-03 in the amount of \$4,500,000 to be appropriated within the Public Works Department for said project.

SECTION 2: The aforesaid adjustments shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

SECTION 3: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: This ordinance shall become effective upon signature of the Lafayette City-Parish President, the elapse of ten (10) days after receipt by the Lafayette City-Parish President without signature or veto, or upon an override of a veto, whichever occurs first.
