**A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND THE
LAFAYETTE PARISH COUNCIL AMENDING THE FY 21/22 OPERATING BUDGET
OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY
INCREASING REVENUES IN THE AMOUNT OF \$122,589.46 IN HOME INVESTMENT
PARTNERSHIPS FUNDS RECEIVED FROM THE PAYMENT OF LOANS FUNDED BY
THE HOME PROGRAM AND APPROPRIATING FUNDS WITHIN THE COMMUNITY
DEVELOPMENT AND PLANNING DEPARTMENT**

BE IT ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:


SECTION 1: The FY 21/22 operating budget of the Lafayette City-Parish Consolidated Government is hereby amended by increasing revenues in the amount of \$122,589.46 in HOME Investment Partnerships (HOME) Program funds, received as program income from the payment of loans funded by the HOME program, and appropriating funds within the Community Development and Planning Department.

SECTION 2: This increase in revenues shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

SECTION 3: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.




