A RESOLUTION OF THE LAFAYETTE CITY COUNCIL OFFICIALLY DESIGNATING FIGHTINGVILLE FRESH IN THE CITY OF LAFAYETTE AS A RECOGNIZED LOUISIANA FESTIVAL OR FAIR AS PROVIDED FOR BY LA. R.S. 40:4.5 AND TITLE 51, PART XXIII OF THE LOUISIANA ADMINISTRATIVE CODE

BE IT RESOLVED by the Lafayette City Council, that:

WHEREAS, Fightingville Fresh will serve as a farmers' market that sells fresh produce from local farmers and producers; and

WHEREAS, Fightingville Fresh is also a space that will provide value-added food products; and

WHEREAS, Fightingville Fresh will be a market that will address nutritional disparities among the Fightingville neighborhood and the north side of the City of Lafayette and will offer communal benefits for residents; and

WHEREAS, Fightingville Fresh wishes to conduct a market in the City of Lafayette; and

WHEREAS, it is the intent of the Lafayette City Council that Fightingville Fresh should be included as a Food Fair and Festival.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Lafayette City Council, that:

**SECTION 1:** All of the aforedescribed "Whereas" clauses are adopted as part of this resolution.

SECTION 2: The Lafayette City Council hereby requests the State Office of Public Health and the Lafayette Parish Health Unit officially designate Fightingville Fresh as an official State Fair and Festival.

**SECTION 3:** All resolutions, or parts thereof, in conflict herewith are hereby repealed.


