**AN ORDINANCE OF THE LAFAYETTE CITY COUNCIL AMENDING THE FY 21/22
CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED
GOVERNMENT BY TRANSFERRING \$925,000.00 FROM THE COMPLETED E PONT
DES MOUTON ROAD WIDENING PROJECT TO THE LAKE FARM ROAD
EXTENSION (KALISTE SALOOM TO SETTLERS TRACE) PROJECT WITHIN THE
PUBLIC WORKS DEPARTMENT, CAPITAL IMPROVEMENTS DIVISION TO
CREATE PROJECT ACCOUNT**

BE IT ORDAINED by the Lafayette City Council, that:

SECTION 1: The FY 21/22 capital budget of the Lafayette City-Parish Consolidated Government is hereby amended by transferring \$925,000.00 from the completed E Pont Des Mouton Road Widening project to the Lake Farm Road Extension (Kaliste Saloom to Settlers Trace) project within the Public Works Department, Capital Improvements Division to create project account.

SECTION 2: This transfer of funds shall be reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

SECTION 3: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.


