

PARISH ORDINANCE NO. PO-035-2022

AN ORDINANCE OF THE LAFAYETTE PARISH COUNCIL AMENDING THE FY 21/22 CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY INCREASING DIRECT NON-RECURRING REVENUES FROM THE STATE OF LOUISIANA GENERAL FUND FOR THE BAYOU VERMILION FLOOD CONTROL, PLANNING AND CONSTRUCTION PROJECT 50-J28-21-02 IN THE AMOUNT OF \$22,000,000 AND APPROPRIATING THESE FUNDS WITHIN THE PUBLIC WORKS DEPARTMENT, CAPITAL IMPROVEMENTS DIVISION FOR SAID PROJECT

BE IT ORDAINED by the Lafayette Parish Council, that:

SECTION 1: The FY 21/22 capital budget of the Lafayette City-Parish Consolidated Government is hereby amended by increasing direct non-recurring revenues from the State of Louisiana General Fund for the Bayou Vermilion Flood Control, Planning and Construction Project 50-J28-21-02 in the amount of \$22,000,000 and appropriating these funds within the Public Works Department, Capital Improvements Division for said project.

SECTION 2: The aforesaid adjustments shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

SECTION 3: The Lafayette Mayor-President is hereby authorized to execute any and all documents, including but not limited to a Cooperative Endeavor Agreement, together with any amendments or necessary modifications thereto, including but not limited to, agreements, budget adjustments and revisions, together with any amendments or necessary modifications thereto, necessary to carry out the dictates of this Ordinance and construct said project.

SECTION 4: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 5: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.


