**AN ORDINANCE OF THE LAFAYETTE CITY COUNCIL AMENDING THE FY 21/22
CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED
GOVERNMENT BY TRANSFERRING \$150,000 FROM THE COMPLETED CIDC, LAT
7 CURRAN/DULLES PROJECT TO THE RECREATION CENTER IMPROVEMENTS
ACCOUNT WITHIN THE PARC DEPARTMENT FOR ADDITIONAL FUNDING
NEEDED FOR THE LCG GIRARD PARK REC CENTER ROOF REPLACEMENT
PROJECT**

BE IT ORDAINED by the Lafayette City Council, that:

SECTION 1: The FY 21/22 capital budget of the Lafayette City-Parish Consolidated Government is hereby amended by transferring \$150,000 from the completed CIDC, Lat 7 Curran/Dulles project to the Recreation Center Improvements account within the PARC Department for additional funding needed for the Lafayette Consolidated Government Girard Park Recreation Center Roof Replacement project.

SECTION 2: The aforesaid adjustments shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of Council.

SECTION 3: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.




