

ORDINANCE NO. JO-102-2022

A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND THE LAFAYETTE PARISH COUNCIL AUTHORIZING THE FILING OF APPLICATIONS FOR GRANT FUNDING WHICH MAY BECOME AVAILABLE TO THE COMMUNITY DEVELOPMENT AND PLANNING DEPARTMENT OF LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT

BE IT ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

WHEREAS, the Community Development and Planning Department of Lafayette City-Parish Consolidated Government (“CD&P”) occasionally becomes eligible for various grant opportunities offered by Federal, State, and other agencies; and

WHEREAS, the time frame for CD&P application submittals for grant funds may not allow adequate time to meet Lafayette City Council and/or Lafayette Parish Council deadlines for the submittal of items for consideration by ordinance; and

WHEREAS, considering the foregoing, the Lafayette City Council and the Lafayette Parish Council desire, through this joint ordinance, to grant general authorization to CD&P to submit applications for grant funds without the necessity of individualized Lafayette City Council and/or Lafayette Parish Council approval on a case by case basis.

NOW THEREFORE, BE IT FURTHER ORDAINED by the Lafayette City Council and Lafayette Parish Council, that:

SECTION 1: All of the aforescribed “Whereas” clauses are adopted as part of this ordinance.

SECTION 2: CD&P is hereby authorized to submit applications for grant funds. However, this joint ordinance does not authorize any appropriation or recognition of any revenue or incurring any financial obligation without the approval(s) of the appropriate Council(s).

SECTION 3: The Lafayette City Council and the Lafayette Parish Council further authorizes the Lafayette Mayor-President and the Director of CD&P, or either of them, or their respective designees, to conduct all negotiations, execute, and submit all documents, including but not limited to, applications, agreements, amendments, payment requests, memoranda of understanding and similar or related documents, which may be necessary, convenient, or desirable, in their judgment, for the completion of the prospective grant applications authorized by this joint ordinance.

SECTION 4: Except for Ordinance No. O-033-2007, all ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 5: EFFECTIVE DATE. After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City

Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.


SUBJ: *COMMUNITY DEVELOPMENT & PLANNING AUTHORIZATION RELATED TO GRANT FUNDING*

Enclosed for your review and consideration is a proposed joint ordinance of the Lafayette City Council and the Lafayette Parish Council authorizing the filing of applications for grant funding which may become available to the Community Development and Planning Department of Lafayette City-Parish Consolidated Government.

This ordinance will allow our department to apply for grants without first having to obtain a Council resolution in support of the potential application. Often times, there are short application deadlines once a Notice of Funding Opportunity is issued and having to go through this Council process delays, and many times disqualifies, our ability to apply for the grant.

This ordinance will continue to require that we obtain Council approval to appropriate the grant award monies over \$10,000 as well as allocate any required match monies. It also gives the Mayor-President to sign applications, agreements, contract, etc. relative to these grants which is especially important for grants which are less than \$10,000 and have no match as outlined in Ordinance No. O-033-2007.

If all is in order, please submit for introduction on the December 6, 2022 Joint Council agenda and adoption on the December 20, 2022 Joint Council agenda.
