PARISH ORDINANCE NO. PO-019-2023

AN ORDINANCE OF THE LAFAYETTE PARISH COUNCIL RE-ESTABLISHING THE APPOINTMENT TO AND COMPOSITION OF THE MEMBERSHIP OF THE LAFAYETTE PARISH LIBRARY BOARD OF CONTROL

BE IT ORDAINED by the Lafayette Parish Council, that:

WHEREAS, the Lafayette Parish Council desires to re-establish the method of appointment of the Lafayette Parish Library Board of Control ("Board") consistent with state law.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Lafayette Parish Council, that:

SECTION 1: All of the aforedescribed "Whereas" clauses are adopted as part of this ordinance.

SECTION 2: In accordance with La. R.S. 25:214(B), the Lafayette Parish Council hereby re-establishes the method of appointment of the Board, as follows:

The Lafayette Parish Council shall appoint seven (7) members to the Board, each of which shall be a citizen of the Parish of Lafayette. The Chair of the Lafayette Parish Council shall be, ex officio, a member of the Board, provided however that the Chair shall have the right to designate another member of the governing authority of the parish to serve in his/her place and stead on the Board in accordance with La. R.S. 25:214(B).

SECTION 3: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the clapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.
