PARISH ORDINANCE NO. PO-043-2023

AN ORDINANCE OF THE LAFAYETTE PARISH COUNCIL AUTHORIZING AND DIRECTING THE LAFAYETTE MAYOR-PRESIDENT TO EXECUTE AND SUBMIT THE "TEMPORARY HOUSING AND SHELTER ASSISTANCE PROGRAM WAIVER OF LAND USE/PERMITTING FORM" IN ACCORDANCE WITH LA. R.S. 29:726(F)(3)(b)(iii)(2a)

BE IT ORDAINED by the Lafayette Parish Council, that:

WHEREAS, the Lafayette Parish Council, as the governing authority for the Parish of Lafayette, desires to participate in the Temporary Housing and Shelter Assistance Program ("Program") within the Governor's Office of Homeland Security and Emergency Preparedness ("GOHSEP"); and

WHEREAS, in accordance with La. R.S. 29:726(F)(3)(b)(iii)(aa) (Act 526, 2022), one (1) of the requirements for eligibility to participate in this Program is a certification from the local governing authority that it will waive any land use regulations relative to permitting for the temporary placement and occupancy of mobile homes, recreational vehicles (RV's), and/or other temporary housing directly adjacent to the disaster survivor's damaged dwelling to allow for expedited temporary housing assistance in the Parish of Lafayette.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Lafayette Parish Council, that:

SECTION 1: All of the aforedescribed "Whereas" clauses are adopted as part of this parish ordinance.

SECTION 2: In accordance with La. R.S. 29:726(F)(3)(b)(iii)(aa) (Act 526, 2022), the Lafayette Parish Council, as the governing authority for the Parish of Lafayette, hereby authorizes and directs the Lafayette Mayor-President to execute and submit the attached form from the Governor's Office of Homeland Security and Emergency Preparedness (GOHSEP), entitled "Temporary Housing and Shelter Assistance Program Waiver of Land Use/Permitting Form," certifying that the Parish of Lafayette opts in to the Temporary Housing and Shelter Assistance Program.

SECTION 3: This waiver of land use regulations relative to the permitting of temporary housing, provided herein, shall only be effective for such period as required by the Temporary Housing and Shelter Assistance Program.

SECTION 4: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 5: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.
