## ORDINANCE NO. JO-056-2023

A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND LAFAYETTE PARISH COUNCIL AMENDING CHAPTER 6, ARTICLE III, DIVISION 2, SECTION 6-94 OF THE LAFAYETTE CONSOLIDATED GOVERNMENT CODE OF ORDINANCES RELATIVE TO THE HOURS OF THE SALE, DISPENSING, AND DELIVERY OF BEVERAGES WITH LOW ALCOHOLIC CONTENT ON SUNDAYS WITHIN THE CITY OF LAFAYETTE AND UNINCORPORATED AREAS OF LAFAYETTE PARISH

BE IT ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

WHEREAS, to promote and protect the health, safety, and welfare of the people of the City of Lafayette and the unincorporated areas of Lafayette Parish while at the same time promoting and fostering business development in the City of Lafayette and the Parish of Lafayette, the Lafayette City Council and the Lafayette Parish Council desire to amend Chapter 6, Article III, Division 2, Section 6-94 of the Lafayette City-Parish Consolidated Government Code of Ordinances relative to the hours of the sale, dispensing, and delivery of beverages with low alcoholic content on Sundays within the City of Lafayette and unincorporated areas of Lafayette Parish.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

**SECTION 1:** All of the aforedescribed "Whereas" clauses are adopted as part of this ordinance.

SECTION 2: Chapter 6, Article III, Division 2, Section 6-94 of the Lafayette City-Parish Consolidated Government Code of Ordinances is hereby amended in the following particulars only, with words in strikethrough being deletions from existing law, and words underscored and boldfaced being additions:

Sec. 6-94. – Sale, consumption and closing hours at establishments licensed for on-premises consumption.

- (a) It is hereby prohibited for outlets to sell, dispense, or deliver beverages with high and/or-low alcoholic content for on-the-premises consumption and/or deliveries between the hours of 2:00 a.m. and 41:007:00 a.m. on Sundays, between the hours of 12:00 midnight and 6:00 a.m. on Mondays, and between the hours of 2:00 a.m. and 6:00 a.m. on Tuesdays, Wednesdays, Thursdays, Fridays and Saturdays. The consumption of any alcohol on such premises is prohibited after 12:30 a.m. on Mondays and after 2:30 a.m. on all other days of the week.
- (b) It is hereby prohibited for outlets to sell, dispense, or deliver beverages with high alcoholic content for on-the-premises consumption and/or deliveries between the hours of 2:00 a.m. and 11:00 a.m. on Sundays, between the hours of 12:00 midnight and 6:00 a.m. on Mondays, and between the hours of 2:00 a.m. and 6:00 a.m. on Tuesdays, Wednesdays, Thursdays, Fridays and Saturdays. The consumption of any alcohol on such premises is prohibited after 12:30 a.m. on Mondays and after 2:30 a.m. on all other days of the week.

(b)(c) No person shall be allowed to remain on the premises after 12:30 a.m. Monday and 2:30 a.m. on all the other days of the week except permit holders, paid employees and contractual service workers. Any and all individuals must leave such premises and remain off such premises continuously. The prohibitions contained in this subsection do not apply to bowling alleys or bowling lanes.

**SECTION 3:** All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.
