### PARISH ORDINANCE NO. PO-071-2023

AN ORDINANCE OF THE LAFAYETTE PARISH COUNCIL AMENDING THE FY 23/24 OPERATING BUDGET AND MANNING TABLES OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY ADJUSTING THE SALARIES OF THE REGISTERED NURSES WITHIN THE HEALTH UNIT DIVISION AND JUVENILE DETENTION CENTER, PER CIVIL SERVICE RECOMMENDATION

BE IT ORDAINED by the Lafayette Parish Council, that:

SECTION 1: The FY 23/24 operating budget and manning tables of the Lafayette City-Parish Consolidated Government is hereby amended by adjusting the salaries of the Registered Nurses within the Health Unit Division and Juvenile Detention Center, per Civil Service recommendation. The salaries of five (5) Registered Nurses within the Health Unit will be increased with an annual cost of \$78,510 and the salary of one (1) Registered Nurse within the Juvenile Detention Center will be increased with an annual cost of \$7,665.

SECTION 2: This adjustment shall be as reflected in any pertinent document(s) which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

**SECTION 3:** All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.
