PARISH ORDINANCE NO. PO-074-2023

AN ORDINANCE OF THE LAFAYETTE PARISH COUNCIL AMENDING THE FY 23/24 OPERATING BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY INCREASING THE USE OF THE CREATE FUND'S (274) PRIOR YEAR FUND BALANCE IN THE AMOUNT OF \$303,120 AND APPROPRIATING WITHIN THE LAFAYETTE MAYOR-PRESIDENT'S OFFICE TO REPLACE TECHNICAL EQUIPMENT WITHIN THE ACADIANA CENTER FOR THE ARTS (ACA) BUILDING

BE IT ORDAINED by the Lafayette Parish Council, that:

SECTION 1: The FY 23/24 operating budget of the Lafayette City-Parish Consolidated Government is hereby amended by increasing the use of the CREATE Fund's Prior Year Fund Balance in the amount of \$303,120 and appropriating within the Lafayette Mayor-President's Office to replace technical equipment with in the ACA Building.

SECTION 2: This transfer of funds shall be reflected in any pertinent documents which are attached and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

SECTION 3: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.

AcA Technical Equipment Replacements V2

Three LCG-owned technical systems in AcA are approaching or have surpassed their viable lifespan. In some cases, the equipment has already failed and work is only continuing due to equipment rented at a significant expense. In other cases, AcA has purchased temporary refurbished equipment that will have a much shorter lifespan or has been keeping equipment temporarily operable through continual maintenance.

As the building reaches 20 years in age in 2024, AcA is seeking to plan for the appropriate replacement of this critical technical equipment, all of which is property of LCG, in three categories: Lighting; Sound and Recording; and Video.


This equipment is heavily used year-round to produce more than 150 public events taking place at the AcA, and all of it is essential to the success of virtually any scale at AcA. These events and the equipment that serves as the key infrastructure for their production all work within the public good and serve the mission of the Acadiana Center for the Arts and the CEA between the AcA and LCG to promote cultural activity and economic activity in the heart of Lafayette.

While looking at necessary replacements, AcA has also identified how specific one-time investments in new hardware could allow for the venue to operate more continuously—and more sustainably—as not just a live event venue but also as a recording studio for film industry scoring projects. Film scoring projects require a large studio-quality environment like the AcA theater, and such an environment the size of AcA does not otherwise exist in Lafayette Parish (or anywhere else in Louisiana for that matter). AcA is currently under consideration by Louisiana Entertainment for a multi-year major investment that would bring more than 70 jobs in the music and entertainment sector to Lafayette through the development of this recording studio initiative at AcA. That new initiative would require AcA's technology to be fully updated as described below.

Below is a summary of the equipment expected to be needed over the course of the next 24 months in order to keep the facility modern and to enable the high quality of production that the public and our partners have come to expect. These purchases are estimated at approximately \$303,120.00 and could take place over a 24 month period.



On top of this requested capital budget from LCG, AcA is under consideration for in excess of \$750,000 in investment from Louisiana Entertainment, which would be focused on recording-specific equipment, training of musicians, and marketing and development of the film scoring studio initiative.
