CITY ORDINANCE NO. CO-188-2023

AN ORDINANCE OF THE LAFAYETTE CITY COUNCIL AMENDING THE FY 23/24 OPERATING AND CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY DECREASING THE USE OF FUND BALANCE IN THE DOWNTOWN DRAINAGE PROJECT IN THE AMOUNT OF \$2,259,741, DECREASING THE USE OF FUND BALANCE IN THE SPOT DREDGING VERMILION PROJECT IN THE AMOUNT OF \$730,259, AND APPROPRIATING SAID FUNDS TO THE LAKE FARM ROAD DETENTION PROJECT, FOR ADDITIONAL FUNDS TO COMPLETE THE ACQUISITION, BY EXPROPRIATION, OF THE NECESSARY RIGHTS-OF-WAY, IMMOVABLE PROPERTY, AND OTHER PROPERTY RIGHTS REQUISITE TO THE CONSTRUCTION OF THE LAKE FARM ROAD DETENTION PROJECT

BE IT ORDAINED by the Lafayette City Council, that:

WHEREAS, on March 9, 2021, the Lafayette City Council adopted City Ordinance No. CO-030-2021 declaring the Lake Farm Road Detention Project ("Project") a public necessity and authorizing the Lafayette Mayor-President to acquire all necessary rights-of-way, immovable property and other property rights requisite to the construction of said Project, either on an amicable basis or through the use of the expropriation process, if necessary; and

WHEREAS, as part of the Project, it became necessary to expropriate certain immovable property and rights related thereto and, in order to effectuate said expropriation, funds were deposited into the registry of the Court in accordance with applicable law; and

WHEREAS, additional funds are now needed to complete the expropriation of certain immovable property and rights related thereto, the same being necessary for the completion of the Project.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Lafayette City Council, that:

SECTION 1: All of the aforedescribed "Whereas" clauses are adopted as part of this ordinance

SECTION 2: The FY 23/24 operating budget of the Lafayette City-Parish Consolidated Government ("LCG") is hereby amended to decrease the use of the fund balance in the Downtown Drainage Project in the amount of \$2,259,741, to decrease the use of fund balance in the Spot Dredging Vermilion Project in the amount of \$730,259, and to appropriate said funds to the Lake Farm Road Detention Project, for additional funds for purposes of completing the expropriation of certain immovable property and rights related thereto, the same being necessary for the completion of the Project.

SECTION 3: This amendment shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council. The Chief Financial Officer of LCG is authorized to prepare any and all internal and/or

administrative budget revisions and do all other acts necessary to comply with the dictates of this ordinance.

SECTION 4: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 5: This ordinance shall become effective upon signature of the Lafayette Mayor-President or the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature, whichever occurs first.
