

ORDINANCE NO. JO-019-2024

**A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND THE LAFAYETTE PARISH COUNCIL AMENDING THE FY 23/24 OPERATING BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY AUTHORIZING THE AMENDMENT OF ORDINANCE NO. JO-072-2022 TO TRANSFER AN ADDITIONAL \$25,000 IN COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS WITHIN THE COMMUNITY DEVELOPMENT AND PLANNING DEPARTMENT TO THE EXTRA MILE**

**BE IT ORDAINED** by the Lafayette City Council and the Lafayette Parish Council, that:

**WHEREAS**, through previous Ordinance No. JO-072-2022, The Extra Mile received \$75,000 in Community Development Block Grant (CDBG) funding from the Community Development and Planning Department for the purpose of upgrading the sewer system at the Meredith's Place Residential Facility; and

**WHEREAS**, The Extra Mile now requests an additional \$25,000 in CDBG funds to cover additional costs related to the project because the bid cost was higher than expected.

**NOW, THEREFORE, BE IT FURTHER ORDAINED** by the Lafayette City Council and the Lafayette Parish Council, that:

**SECTION 1:** All of the aforescribed "Whereas" clauses are adopted as part of this ordinance.

**SECTION 2:** The FY 23/24 operating budget of the Lafayette City-Parish Consolidated Government is hereby amended by transferring \$25,000 in Community Development Block Grant (CDBG) funds within the Community Development and Planning Department from Reserve Grants/Contracts to The Extra Mile for use in the Meredith's Place Residential Facility Sewer Replacement System. Funds will be used for U.S. Department of Housing and Urban Development (HUD) approved activities that benefit low- to moderate- income persons.

**SECTION 3:** The Lafayette Parish Council and the Lafayette City Council hereby authorize the Lafayette Mayor-President, or her designee, to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, payment requests, memoranda of understanding and so on, which may be necessary for the completion of the aforementioned project.

**SECTION 4:** This transfer of funds shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Lafayette Clerk of the Council.

**SECTION 5:** All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

**SECTION 6:** After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.


