**AN ORDINANCE OF THE LAFAYETTE CITY COUNCIL AMENDING THE FY 23/24 CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY INCREASING REVENUES IN THE AMOUNT OF \$24,000 RECEIVED FROM THE LAFAYETTE CONVENTION AND VISITORS COMMISSION FOR THE PURPOSE OF FUNDING THE UPCOMING LOUISIANA RECREATION AND PARKS ASSOCIATION CONFERENCE HOSTED BY LAFAYETTE CONSOLIDATED GOVERNMENT'S DEPARTMENT OF PARKS, ARTS, RECREATION AND CULTURE**

**BE IT ORDAINED** by the Lafayette City Council, that:

**SECTION 1:** The FY 23/24 Capital Budget of the Lafayette City-Parish Consolidated Government is hereby amended by increasing revenues in the amount of \$24,000 received from the Lafayette Convention and Visitors Commission for the purpose of funding the upcoming Louisiana Recreation and Parks Association Conference hosted by Lafayette Consolidated Government's Department of Parks, Arts, Recreation and Culture.

**SECTION 2:** This transfer of funds shall be reflected in any pertinent documents which are attached and made a part hereof and filed in the Office of the Clerk of the Council.

**SECTION 3:** All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

**SECTION 4:** This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.


