ORDINANCE NO. JO-038-2024

A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND THE LAFAYETTE PARISH COUNCIL REPEALING THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT CODE OF ORDINANCES CONCERNING EMERGENCY MANAGEMENT, CHAPTER 30

BE IT ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

WHEREAS, the Lafayette City-Parish Consolidated Government Code of Ordinances concerning Emergency Management, Chapter 30, which dates to no more recently than 1977 is outdated, and is not in compliance with current law, La. R.S. 29:721-39, Chapter 6, The Louisiana Homeland Security and Emergency Assistance and Disaster Act; and

WHEREAS, Lafayette City-Parish Consolidated Government Code of Ordinances concerning Emergency Management, Chapter 30, should be repealed in its entirety.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

SECTION 1: All of the aforedescribed "Whereas" clauses are adopted as part of this ordinance.

SECTION 2: Lafayette City-Parish Consolidated Government Code of Ordinances concerning Emergency Management, Chapter 30, is hereby repealed in its entirety.

SECTION 3: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.
