BE IT RESOLVED by the Lafayette Parish Council, that:

WHEREAS, the Lafayette City-Parish Consolidated Government ("LCG") is party to an executed Cooperative Endeavor Agreement with the State of Louisiana (the "State") for the Milton Volunteer Fire Department Project (the "Project"); and

**WHEREAS,** the State currently has \$238,750 in unobligated funds that could potentially be budgeted toward construction of the Project; and

WHEREAS, the current Project cost estimate is \$242,000.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** by the Lafayette Parish Council, that:

**SECTION 1:** All of the aforedescribed "Whereas" clauses are adopted as part of this resolution.

**SECTION 2:** LCG hereby commits and obligates itself to fund all costs inclusive of design costs, construction costs and potential change orders for the Project that exceed the available State funding.

**SECTION 3:** All resolutions, or parts thereof, in conflict herewith are hereby repealed.


