BE IT RESOLVED by the Lafayette Parish Council, that:

WHEREAS, the Lafayette City-Parish Consolidated Government ("LCG") is party to an executed Cooperative Endeavor Agreement with the State of Louisiana (the "State") for the Parish Road Overlay Project (the "Project"); and

WHEREAS, the State currently has \$955,000 in unobligated funds that could potentially be budgeted toward construction of the Project; and

WHEREAS, the current Project cost estimate is \$1,500,000.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Lafayette Parish Council, that:

SECTION 1: All of the aforedescribed "Whereas" clauses are adopted as part of this resolution.

SECTION 2: LCG hereby commits and obligates itself to fund all costs inclusive of construction costs and potential change orders for the Project that exceed the available State funding, such excess costs being estimated to be \$545,000.

SECTION 3: All resolutions, or parts thereof, in conflict herewith are hereby repealed.


