#### ORDINANCE NO. JO-050-2024

A JOINT ORDINANCE OF THE LAFAYETTE CITY COUNCIL AND THE LAFAYETTE PARISH COUNCIL APPROVING THE COMMUNITY DEVELOPMENT AND PLANNING DEPARTMENT, HUMAN SERVICES DIVISION, HOUSING COUNSELING PROGRAM PROVIDING HOUSING COUNSELING SERVICES TO THE RESIDENTS OF LAFAYETTE, LOUISIANA AND THE SURROUNDING AREAS

WHEREAS, the Community Development and Planning Department, Human Services Division, Housing Counseling Program, also known as 'Neighborhood Counseling Services'

BE IT ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

supports efforts toward affordable and sustainable housing for the residents of the City of Lafayette

and Lafayette Parish; and

WHEREAS, the Housing Counseling Program continues to provide housing counseling services to the residents of Lafayette, Louisiana and surrounding communities in accordance with 24 CFR 214.103(a).

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Lafayette City Council and the Lafayette Parish Council, that:

**SECTION 1:** All of the aforedescribed "Whereas" clauses are adopted as part of this joint ordinance.

SECTION 2: The Housing Counseling Program is approved for the continued authority to provide such housing counseling services to the residents of Lafayette, Louisiana through HUD certified counseling staff following all applicable HUD counseling guidelines, policies, and procedures.

SECTION 3: The Lafayette Mayor-President is hereby authorized to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, memorandums of understanding, payment requests and so on, which may be necessary during the course of the program.

SECTION 4: This policy may undergo minor updates, as necessary, to ensure Lafayette City-Parish Consolidated Government remains in compliance with Housing Counseling regulations, as required by HUD.

**SECTION 5:** All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 6: After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-

President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.
