SECTION 1: Ordinance JO-001-2021 which created a conditional two (2%) percent pay increase structure for employees of the Office of the City Marshal, is hereby suspended for the proposed FY 24/25 budget as a result of the adoption of the City Marshal pay plan funded in FY 23/24.

SECTION 2: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 3: After first having been adopted by a majority of the authorized membership of both the Lafayette Parish Council and the Lafayette City Council, this joint ordinance shall become effective upon signature of this joint ordinance by the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon override of a veto, whichever occurs first.
