**AN ORDINANCE OF THE LAFAYETTE CITY COUNCIL AMENDING THE FY 24/25 CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY TRANSFERRING \$817,952.17 FROM VARIOUS PROJECTS TO THE WILLOW STREET OVERLAY PROJECT AND APPROPRIATING WITHIN THE PUBLIC WORKS DEPARTMENT TO CREATE PROJECT ACCOUNT**

**BE IT ORDAINED** by the Lafayette City Council, that:

**SECTION 1:** The FY 24/25 capital budget of the Lafayette City-Parish Consolidated Government is hereby amended by transferring \$817,952.17 from various projects to the Willow Street Overlay Project and appropriating within the Public Works Department to create project account.

**SECTION 2:** The aforesaid adjustments shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Clerk of Council.

**SECTION 3:** All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

**SECTION 4:** This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.
