

**PARISH ORDINANCE NO. PO-061-2024**

**AN ORDINANCE OF THE LAFAYETTE PARISH COUNCIL AMENDING THE FY 24/25 OPERATING AND CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY INCREASING REIMBURSEMENT REVENUES FROM STATE OF LOUISIANA FACILITY PLANNING AND CONTROL FOR RUE DU BELIER WIDENING, PLANNING AND CONSTRUCTION PROJECT NO. 50-J28-23-07 IN THE AMOUNT OF \$1,000,000 AND ACCOUNTING FOR THE REQUIRED MATCH OF \$333,333 AND APPROPRIATING WITHIN THE PUBLIC WORKS DEPARTMENT**

**BE IT ORDAINED** by the Lafayette Parish Council, that:

**SECTION 1:** The FY 24/25 operating and capital budget of the Lafayette City-Parish Consolidated Government is hereby amended by increasing reimbursement revenues from State of Louisiana Facility Planning and Control for Rue du Belier Widening, Planning and Construction Project No. 50-J28-23-07 in the amount of \$1,000,000 and accounting for the required match of \$333,333 and appropriating within the Public Works Department.

**SECTION 2:** The aforesaid adjustments shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Clerk of Council.

**SECTION 3:** All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

**SECTION 4:** This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.
