**AN ORDINANCE OF THE LAFAYETTE CITY COUNCIL AMENDING THE FY 24/25
CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED
GOVERNMENT BY TRANSFERRING \$1,207,701.81 FROM THE WEBB COULEE
DETENTION PROJECT TO THE MOUTON PARK IMPROVEMENTS PROJECT AND
APPROPRIATING WITHIN THE PUBLIC WORKS DEPARTMENT TO CREATE NEW
LINE ITEM**

BE IT ORDAINED by the Lafayette City Council, that:

SECTION 1: The FY 24/25 capital budget of the Lafayette City-Parish Consolidated Government is hereby amended by transferring \$1,207,701.81 from the Webb Coulee Detention Project to the Mouton Park Improvements Project and appropriating within the Public Works Department to create new line item.

SECTION 2 The aforesaid adjustments shall be as reflected in any pertinent documents which are attached hereto and made a part hereof and filed in the Office of the Clerk of the Council.

SECTION 3: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 4: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.
