**A RESOLUTION OF THE LAFAYETTE PARISH COUNCIL COMMITTING TO THE
STATE OF LOUISIANA FUNDING FOR PROJECT 50-J28-04B-03, PARISH
COURTHOUSE**

BE IT RESOLVED by the Lafayette Parish Council, that:

WHEREAS, the Lafayette City-Parish Consolidated Government (“LCG”) is party to an executed Cooperative Endeavor Agreement with the State of Louisiana (the “State”) for the Parish Courthouse, Phase 3 Project (the “Project”); and

WHEREAS, the State currently has \$1,345,393.17 in unobligated funds that could potentially be budgeted toward construction of the Project; and

WHEREAS, the current Project cost estimate is \$4,182,884.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Lafayette Parish Council, that:

SECTION 1: All of the aforescribed “Whereas” clauses are adopted as part of this resolution.

SECTION 2: LCG hereby commits and obligates itself to fund all costs inclusive of construction costs and potential change orders for the Project that exceed the available State funding, such excess costs being estimated to be \$2,837,490.83.

SECTION 3: All resolutions, or parts thereof, in conflict herewith are hereby repealed.

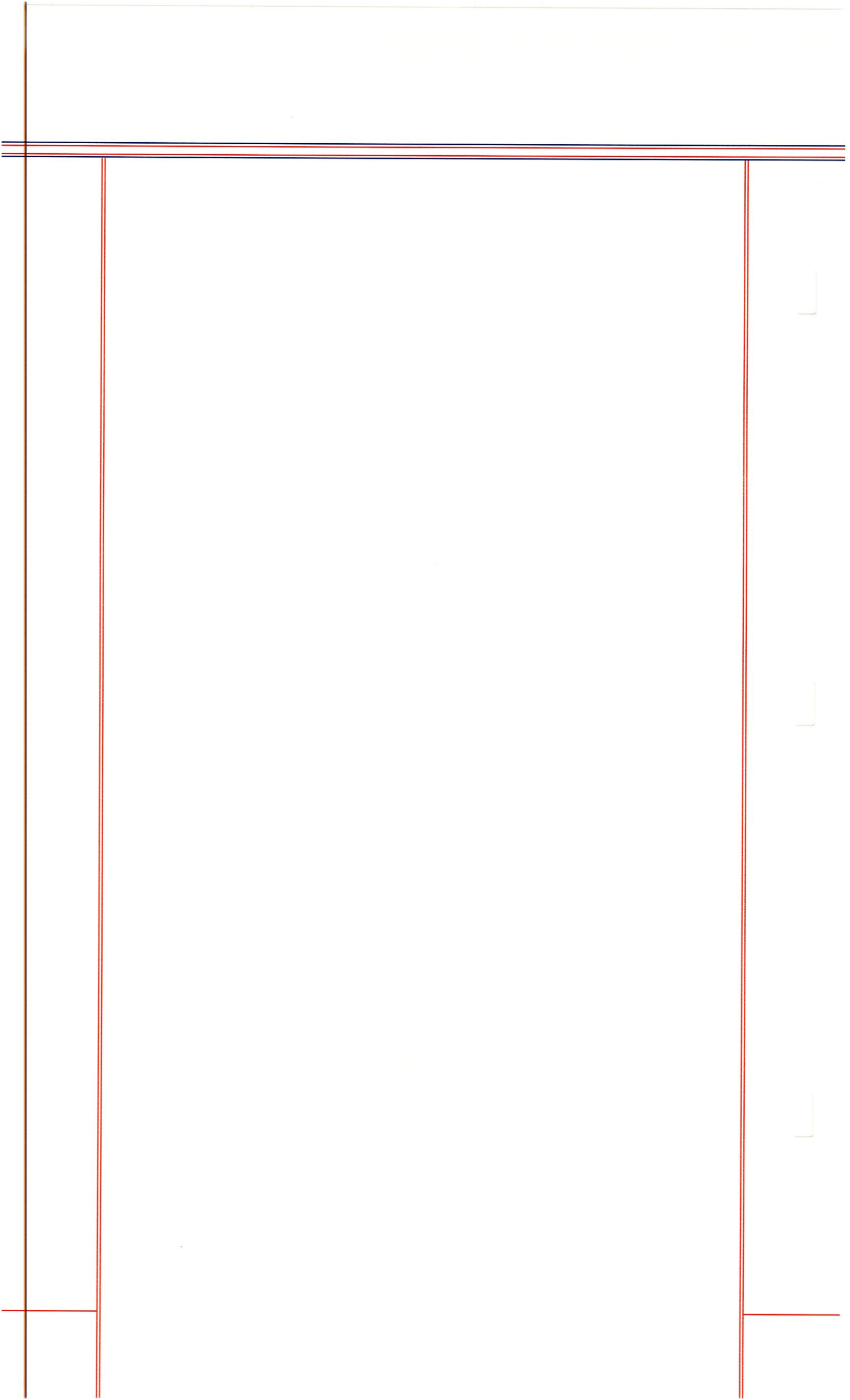
