

**PARISH RESOLUTION NO. PR-018-2025**

**A RESOLUTION OF THE LAFAYETTE PARISH COUNCIL APPROVING THE HOLDING OF AN ELECTION IN THE BAYOU VERMILION DISTRICT, STATE OF LOUISIANA, ON SATURDAY, OCTOBER 11, 2025, TO AUTHORIZE THE RENEWAL OF A SPECIAL TAX THEREIN**

**BE IT RESOLVED** by the Lafayette Parish Council, that:

**WHEREAS**, the Board of Commissioners of the Bayou Vermilion District, State of Louisiana, acting as the governing authority of the Bayou Vermilion District, State of Louisiana (the "District"), adopted a resolution on March 26, 2025, calling a special election in the District on Saturday, October 11, 2025, to authorize the renewal of a special tax therein; and

**WHEREAS**, the District has requested that this Parish Council, acting as the governing authority of the Parish of Lafayette, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to continue to levy and collect the special tax provided for therein; and

**WHEREAS**, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to authorize the District to continue to levy and collect the special tax provided for therein;

**NOW, THEREFORE, BE IT FURTHER RESOLVED** by the Lafayette Parish Council, that:

**SECTION 1:** All of the aforescribed "Whereas" clauses are adopted as part of this resolution.

**SECTION 2:** This Parish Council hereby approves the holding of an election in the District on Saturday, October 11, 2025, at which election there will be submitted the following proposition, to-wit:

**PROPOSITION  
(MILLAGE RENEWAL)**

Shall the Bayou Vermilion District, State of Louisiana (the "District"), continue to levy and collect a special ad valorem tax of 0.75 mills on all the property subject to taxation within the District (an estimated \$2,138,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2027 and ending with the year 2036, for the purpose of constructing, acquiring, improving, operating or maintaining facilities or other public improvements included in the master plan in existence at the time of such expenditure and prepared in the manner provided by Chapter 32, Title 33 of the Louisiana Revised Statutes of 1950, as amended?

**SECTION 3:** In the event the election carries, this Parish Council does hereby further consent to and authorize the District to continue to levy and collect the special tax provided for therein.

**SECTION 4:** All resolutions, or parts thereof, in conflict herewith are hereby repealed.
