[CO-056-2021](#) An ordinance of the Lafayette City Council approving a Conditional Use Permit to allow a dwelling, two (2) family (duplex) in a RS-1 (Residential Single-Family) Zoning District, Case No. ZON2021-0011, 141 Whittington Drive Conditional Use Permit, located generally south of Johnston Street, east of Catherine Street, and west of Oakcrest Drive. (Development and Planning)

[CO-057-2021](#) An ordinance of the Lafayette City Council amending the Lafayette Development Code and the official map of the City of Lafayette, providing for the annexation of additional land into the corporate limits of the City of Lafayette, Louisiana, Case No. ZON2021-0012 600 Block South Domingue Avenue Annexation, located generally north of Ridge Road, east of South Domingue Avenue, and south of Country Hollow Lane, and assigning a zoning classification of RS-1 (Residential Single-Family) and MN-1 (Mixed-Use Neighborhood) (District 2). (Police)

[CO-061-2021](#) An ordinance of the Lafayette City Council amending the FY 20/21 operating budget of the Lafayette City-Parish Consolidated Government by increasing revenues in the amount of \$26,880.00 received from the Louisiana Commission on Law Enforcement (LCLE), authorizing the transfer of matching funds in the amount of \$6,720.00 from Fund 101 and appropriating within the Lafayette Police Department. (Police)
