

PARISH RESOLUTION NO. PR-012-2021

A RESOLUTION OF THE LAFAYETTE PARISH COUNCIL APPROVING THE ACTION TAKEN BY LAFAYETTE ECONOMIC DEVELOPMENT AUTHORITY BOARD OF COMMISSIONERS AUTHORIZING THE TAX ASSESSOR AND TAX COLLECTOR FOR THE PARISH OF LAFAYETTE TO ASSESS AND COLLECT PROPERTY TAXES FOR 2021 FOR THE LAFAYETTE ECONOMIC DEVELOPMENT AUTHORITY

BE IT RESOLVED by the Lafayette Parish Council, that:

WHEREAS, a special meeting of the Board of Commissioners of the Lafayette Economic Development Authority was held on September 27, 2021 to consider a resolution; and

WHEREAS, the Board approved the millage rate for the Lafayette Economic Development Authority of 1.8 mills on the dollar of property subject to taxation situated in the District, which includes all of the Parish of Lafayette, Louisiana, as authorized by law, for the year 2021; and

WHEREAS, the Lafayette Parish Assessor has completed the 2021 reassessment of taxable properties in Lafayette Parish; and

WHEREAS, based on the outcome of the reassessment, there are decreases in net taxable values in Lafayette Parish.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Lafayette Parish Council, that:

SECTION 1: All of the aforescribed “Whereas” clauses are adopted as part of this resolution.

SECTION 2: In a public hearing held on October 5th, 2021, the Lafayette Parish Council adjusted the millage rate to the maximum as follows:

Lafayette Economic Development Authority	1.8 mills

SECTION 3: The proper administrative officers of the Parish of Lafayette, State of Louisiana, be and they are hereby empowered, authorized and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2021, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.


SECTION 4: All resolutions, or parts thereof, in conflict herewith are hereby repealed.

Economic Development 1.80 mills




