

**RESOLUTION NO. JR-040-2021**

**A JOINT RESOLUTION OF THE LAFAYETTE CITY COUNCIL AND THE LAFAYETTE PARISH COUNCIL AUTHORIZING THE FILING OF GRANT APPLICATIONS WITH THE ACADIANA METROPOLITAN PLANNING ORGANIZATION FOR INCLUSION OF VARIOUS PROJECTS IN THE REGIONAL TRANSPORTATION IMPROVEMENT PROGRAM**

**BE IT RESOLVED** by the Lafayette City Council and the Lafayette Parish Council, that:

**WHEREAS**, Ordinance O-124-2015 authorized the Lafayette City-Parish Consolidated Government to enter into an Intergovernmental Agreement by which the Acadiana Metropolitan Planning Organization would assume responsibility for regional transportation planning services; and

**WHEREAS**, the Acadiana Metropolitan Planning Organization has, as a component of its obligations to member agencies, an application process through which it accepts, reviews, and approves applications for various regional projects to be included in the Regional Transportation Improvement Program; and

**WHEREAS**, inclusion in the Regional Transportation Improvement Program is necessary for subsequent inclusion in the State Transportation Improvement Program and its resulting funding; and

**WHEREAS**, a series of projects has been identified by Lafayette City-Parish Consolidated Government as being worthy for inclusion in the Regional Transportation Improvement Program; and

**WHEREAS**, the identified projects are:

1. Carmel Drive Sidewalks; and
2. South College Road Sidewalks; and
3. Citywide Flashing Yellow Arrow Installations; and
4. A Parish-wide Overlay Program; and
5. Roundabout construction at Renaud Drive and Brothers Road; and
6. Roundabout construction at E Broussard Road and Vincent Road; and
7. Transit Access Improvements; and
8. La Neuville Bridge Replacement; and
9. Girouard Road Bridge Replacement; and
10. A Parish-wide Pavement Marking Program; and

**WHEREAS**, subsequent individual ordinances with identified match provisions will be submitted upon approval of any or all of these projects.

**NOW, THEREFORE, BE IT FURTHER RESOLVED** by the Lafayette City Council and the Lafayette Parish Council, that:

**SECTION 1:** All of the aforescribed “Whereas” clauses are adopted as part of this resolution.

**SECTION 2:** The Lafayette City Council and Lafayette Parish Council hereby authorize the Lafayette Mayor-President, or his designee(s), to file project grant applications with

the Acadiana Metropolitan Planning Organization for inclusion in the Regional Transportation Program.

**SECTION 3:** All resolutions, or parts thereof, in conflict herewith are hereby repealed.
