- 14. <u>CO-004-2022</u> An ordinance of the Lafayette City Council amending the Lafayette Development Code so as to reclassify Case No. ZON2021-0039 100 Block Brown Fortier Drive Rezoning, located generally north of Brown Fortier Drive, west of Johnston Street, and south of Duhon Road; the particular parcels being rezoned from CH (Commercial-Heavy) to CM-1 (Commercial Mixed). (Community Development and Planning)
- 15. <u>CO-005-2022</u> An ordinance of the Lafayette City Council amending the Lafayette Development Code so as to reclassify Case No. ZON2021-0043 3300 Block Verot School Road Rezoning, located generally north of Woodstone Drive, east of Verot School Road, and south of Vincent Road; the particular parcels being rezoned from A (Agricultural) to RS-1 (Residential Single-Family) and MN-1 (Mixed-Use Neighborhood). - 16. <u>CO-006-2022</u> An ordinance of the Lafayette City Council amending the Lafayette Development Code and the official map of the City of Lafayette, providing for the annexation of additional land into the corporate limits of the City of Lafayette, Louisiana, Case No. ZON2021-0045 151 West Palermo Road Annexation, located generally north of Bonin Road, east of Sarah Dee Parkway, and south of Barataria Bay Point; and assigning a zoning classification of RS-1 (Residential Single-Family) (District 4). - 17. <u>CO-007-2022</u> An ordinance of the Lafayette City Council amending the Lafayette Development Code and the official map of the City of Lafayette, providing for the annexation of additional land into the corporate limits of the City of Lafayette, Louisiana, Case No. ZON2021-0046 2945 Ambassador Caffery Parkway Annexation, located generally north of West Bonaire Drive, west of Ambassador Caffery Parkway, and south of West Congress Street; and assigning a zoning classification of CM-1 (Commercial Mixed) (District 2).
