PO-005-2022 An ordinance of the Lafayette Parish Council amending the Lafayette City-Parish Consolidated Government Code of Ordinances Chapter 62, Article III "Crimes and Offenses in the Parish," by enacting Section 62-124, "Operating a Watercraft on the Vermilion River, Including Areas Inundated by Floodwaters of the Vermilion River, When the River is at or above Flood Stage," and establishing fines and penalties for violations thereof. (Legal)
- 8 PO-006-2022 An ordinance of the Lafayette Parish Council accepting ownership on behalf of the Parish of Lafavette of rights the State of Louisiana, Department of Transportation and Development may own and responsibilities for the operation and maintenance of same in those certain properties described herein and authorizing the Lafayette Mayor-President to execute all documents necessary to carry out the dictates of this ordinance. JO-014-2022 A joint ordinance of the Lafayette City Council and the Lafayette Parish Council amending the FY 21/22 operating budget and adjusting manning tables of the Lafayette City-Parish Consolidated Government by authorizing the use of PY Fund Balance of the City General Fund (Fund 101) in the amount of \$104,072 and appropriating within the Department of Community Development & Planning, Compliance Division. (Community Development and Planning)
- 22. JO-015-2022 A joint ordinance of the Lafayette City Council and the Lafayette Parish Council amending Chapter 70 of the Lafayette City-Parish Consolidated Government Code of Ordinances by enacting Article IV "Mobile Food Establishments" regarding the permitting and operation of same, and establishing penalties for violations, and amending Chapter 89 of the Lafayette City-Parish Consolidated Government Code of Ordinances, by amending Article 2, Section 89-21-2 "Use Table" and Section 89-21(d) related to mobile food establishments. (Community Development and Planning)
