A RESOLUTION OF THE LAFAYETTE CITY COUNCIL INITIATING AN INVESTIGATION OF THE EXECUTIVE BRANCH OF THE CITY OF LAFAYETTE FOR THE SPECIFIED PURPOSES IDENTIFIED HEREIN PURSUANT TO SECTION 2-08 OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT HOME RULE CHARTER

BE IT RESOLVED by the Lafayette City Council, that:

SECTION 1: Under the authority of Section 2-08 of the Lafayette City-Parish Consolidated Government Home Rule Charter ("Charter"), the Lafayette City Council hereby initiates an investigation of the Executive Branch of the City of Lafayette. The Executive Branch includes the Mayor-President as the Chief Executive Officer and head of the Executive Branch for the City of Lafayette, as well as all officials, officers, employees, departments, offices and agencies over which the Mayor-President exercises general executive and administrative authority, consistent with Sections 1-02 and 3-01 of the Charter.

SECTION 2: The Lafayette City Council further declares that the scope of this investigation shall also include an investigation of third-party entities and/or persons directly or indirectly involved, financially or otherwise, in the subject matters of the specified purposes listed in Section 3 of this Resolution.

SECTION 3: This Investigation shall be for the specified purposes of determining compliance with the Charter, Federal law, State law, Local law, and LCG policies and procedures, related to:

- (i) All drainage-related projects and/or works (including, but not limited to, all transactions, events, occurrences, facts and/or circumstances, financially or otherwise, related directly and/or indirectly thereto), involving the direct or indirect expenditure of public funds, use of personnel, employees, assets and/or resources, either in whole or in part, of the City of Lafayette, for the time period beginning May 1, 2021 through the present date; and
- (ii) The direct or indirect expenditure of public funds, use of personnel, employees, assets and/or resources, either in whole or in part, of the City of Lafayette by the Mayor-President, at the direction of the Mayor-President, or benefiting the Mayor-President, for the time period beginning January 6, 2020 through the present date.

SECTION 4: All resolutions, or parts thereof, in conflict herewith are hereby repealed.
