

PARISH ORDINANCE NO. PO-054-2022

AN ORDINANCE OF THE LAFAYETTE PARISH COUNCIL AMENDING THE FY 21/22 CAPITAL BUDGET OF THE LAFAYETTE CITY-PARISH CONSOLIDATED GOVERNMENT BY DECREASING COUNCIL RESERVES IN FUND 651 AMERICAN RESCUE PLAN 21 -- PARISH FUND IN THE AMOUNT OF \$676,719 AND APPROPRIATING WITHIN THE DRAINAGE DEPARTMENT FOR THE PARISH DRAINAGE FLUSHING SERVICES PROJECT THAT WILL BE PERFORMED ON AN AS NEEDED BASIS

BE IT ORDAINED by the Lafayette Parish Council, that:

SECTION 1: The FY 21/22 capital budget of the Lafayette City-Parish Consolidated Government is hereby amended by decreasing Council Reserves in Fund 651 American Rescue Plan/21 -- Parish Fund in the amount of \$676,719 and appropriating within the Drainage Department for the Parish Drainage Flushing Services Project that will be performed within the Lafayette Parish on an as needed basis.

SECTION 2: This transfer of funds shall be contingent upon the Lafayette City-Parish Consolidated Government's adherence to all applicable federal laws, including 2 CFR Part 200, and all regulations assigned by the U.S. Department of the Treasury in connection with the American Rescue Plan Act of 2021.

SECTION 3: This project is classified as Expenditure Category 6.1 -- Provision of Government Services, as required in the U.S. Department of the Treasury's Compliance and Reporting Guidance.

SECTION 4: The Lafayette Parish Council does hereby authorize the Lafayette Mayor-President, or his designee, to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, payment requests, memoranda of understanding and so on, which may be necessary for the completion of the aforementioned project.

SECTION 5: The transfer of funds shall be reflected in any pertinent documents which are attached hereto and made part hereof and filed in the Office of the Lafayette Clerk of the Council.

SECTION 6: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 7: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.
