VETOED ORDINANCE

2. The Lafayette Mayor-President on Monday, September 19, 2022, returned [Joint Ordinance No. JO-054-2022](#) with one (1) line item vetoed and has provided a statement of explanation which has been published in the Official Journal on Friday, September 23, 2022.

In accordance with Section 2-13(C) of the Lafayette City-Parish Consolidated Government Home Rule Charter, vetoed ordinances shall be submitted to the Lafayette Parish Council and the Lafayette City Council no later than the next regular meeting held after publication of veto statement.

Also, in accordance with Section 2-13(B) of the Lafayette City-Parish Consolidated Government Home Rule Charter, all ordinances vetoed by the Lafayette Mayor-President shall be vetoed in full, except that the Lafayette Mayor-President shall have authority to *veto individual appropriation items in the ordinances adopting the operating and capital improvement budgets and amendments thereto.*

Accordingly, general amendment #51 of Joint Ordinance No. [JO-054-2022](#), has been submitted for Council reconsideration:

[JO-054-2022](#) A joint ordinance of the Lafayette City Council and the Lafayette Parish Council adopting an Operating & Five-Year Capital Improvement Budget of revenues and expenditures for the Lafayette City-Parish Consolidated Government for the fiscal year beginning November 1, 2022 and ending October 31, 2023. (Finance)

- a) **Veto No. 1:** Delete NEW GENERAL AMENDMENT #51 – JOINT K. NAQUIN – Remove all proposed salary increases for Directors and Council employees from the respective funds and preserve salary increases that were approved by the Civil Service Director, to be approved by the Civil Service Board.
