- 24. <u>CO-039-2023</u> An ordinance of the Lafayette City Council authorizing the acceptance of grant funds from the Granting Underserved Municipalities Broadband Opportunities grant program for the development of a fiber to the home network in the rural underserved parishes of Vermilion, Acadia, Iberia, and Evangeline in the amount of \$6,336,453.44 and an additional \$4,178,137.76 of aforementioned parishes contributions, amending the FY 22/23 operating and capital budget of Lafayette City-Parish Consolidated Government by increasing revenues in the amount of \$10,514,591.20, recognizing and appropriating said grant funds, along with an appropriation of required matching funds in the amount of \$1,314,323.90 within the Communications System Department.
