- 10. <u>CO-062-2023</u> An ordinance of the Lafayette City Council authorizing the Lafayette City-Parish Consolidated Government to sell 133 surplus golf carts which are no longer needed for public purposes to Ben Nelson Golf and Utility Vehicles, LLC for a total bid price of \$145,550.00, as per the attached list (Golf Carts). (Finance)
