- 27. <u>CO-119-2023</u> An ordinance of the Lafayette City Council amending and re-enacting Chapter 94, Article II, Subsection 94-57(B) of the Lafayette City-Parish Consolidated Government Code of Ordinances to provide the Director of Utilities or the Director of the Communications System Department with the authority to reserve a portion of the capacity of future facilities for a prospective user upon payment of a deposit of the capital recovery fee by the prospective user. (Utilities)
