## **VETOED ORDINANCE**

13. The Lafayette Mayor-President on Friday, June 28, 2024, returned City Ordinance No. CO-066-2024 vetoed and has provided a statement of explanation which has been published in the Official Journal on Sunday, July 7, 2024.

In accordance with Section 2-13(C) of the Lafayette City-Parish Consolidated Government Home Rule Charter, vetoed ordinances shall be submitted to the Lafayette City Council no later than the next regular meeting held after publication of the veto statement.

Accordingly, City Ordinance No. CO-066-2024, has been submitted for Council reconsideration:

CO-066-2024 An ordinance of the Lafayette City Council approving a Conditional Use Permit to allow a convenience store (with gasoline sales) in a CM-1 (Commercial Mixed) Zoning District, Case No. 2024-13-REZ 1803 West University Avenue CUP (Conditional Use Permit), located generally north of Agnes Street, west of West University Avenue, and south of Silkwood Street. (CD&P)
