CITY ORDINANCE NO. CO-127-2025

AN ORDINANCE OF THE LAFAYETTE CITY COUNCIL AMENDING ORDINANCE NO. O-236-2017 OF THE LAFAYETTE CITY-PARISH COUNCIL TO PROVIDE VETERANS RESIDING IN LAFAYETTE PARISH WITH A 25% DISCOUNT ON WEEKDAY GREEN FEES AT THE MUNICIPAL GOLF COURSES, NAMELY: JAY & LIONEL HEBERT MUNICIPAL, LES VIEUX CHENES, AND THE WETLANDS

BE IT ORDAINED by the Lafayette City Council, that:

WHEREAS, the Lafayette City Council desires to provide the veterans residing in Lafayette Parish with a 25% discount on weekday green fees at the municipal golf courses, namely: Jay & Lionel Hebert Municipal, Les Vieux Chenes, and the Wetlands.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Lafayette City Council, that:

SECTION 1: All of the aforedescribed "Whereas" clauses are adopted as part of this ordinance.

SECTION 2: The golf course fee schedule attached to Ordinance No. O-236-2017, of the Lafayette City-Parish Council, at page five (5), as amended by City Ordinance No. CO-174-2023, is hereby amended by adding two (2) asterisks to "Green Fees — Regular" with an accompanying note that provides as follows: "25% discount on weekdays for veterans residing in Lafayette Parish," all as more fully shown on Exhibit A attached hereto and made a part hereof.

SECTION 3: The golf course fee schedule attached to Ordinance No. O-236-2017, of the Lafayette City-Parish Council, at page six (6), as amended by City Ordinance No. CO-174-2023, is hereby amended by adding two (2) asterisks to "Green Fees - Regular (Weekday)" with an accompanying note that provides as follows: "25% discount for veterans residing in Lafayette Parish," all as more fully shown on Exhibit A attached hereto and made a part hereof.

SECTION 4: All ordinances or resolutions, or parts thereof, in conflict herewith are hereby repealed.

SECTION 5: This ordinance shall become effective upon signature of the Lafayette Mayor-President, the elapse of ten (10) days after receipt by the Lafayette Mayor-President without signature or veto, or upon an override of a veto, whichever occurs first.
