JOINT INTRODUCTORY ORDINANCES

- 4. [JO-011-2026](#) A joint ordinance of the Lafayette City Council and the Lafayette Parish Council adjusting the manning tables and amending the FY 25/26 operating and capital improvement budgets of the Lafayette City-Parish Consolidated Government to reflect certain adjustments and amendments relative to the reorganizations of the Parks, Arts, Recreation & Culture Department, the Capital Improvements Department, the Drainage Department and the Traffic, Roads, and Bridges Department. [JO-014-2026](#) A joint ordinance of the Lafayette City Council and the Lafayette Parish Council, acting in their capacity as the governing authority of the City of Lafayette and the Parish of Lafayette, respectively, providing for the abandonment of a certain portion of a 20' drainage servitude and the dedication of a new 20' drainage servitude on Lot 20 of the Brookshire South Phase I Subdivision, located at 207 Rutherford Court, and authorizing the Lafayette Mayor-President to execute an Act of Abandonment in order to effectuate the abandonment on behalf of the City of Lafayette, Parish of Lafayette, and the Lafayette City-Parish Consolidated Government. (CD&P)

8. [JO-015-2026](#) A joint ordinance of the Lafayette City Council and the Lafayette Parish Council amending Chapter 89 of the Lafayette City-Parish Consolidated Government Code of Ordinances a/k/a the Lafayette Development Code (LDC). (CD&P)
