[CO-033-2026](#) An ordinance of the Lafayette City Council amending the FY 25/26 operating budget of the Lafayette City-Parish Consolidated Government by increasing revenues in the amount of \$28,616 received from the Louisiana Commission on Law Enforcement (LCLE) authorizing the transfer of matching funds in the amount of \$9,539 from Fund 101 and appropriating within the Lafayette Police Department. [CO-037-2026](#) An ordinance of the Lafayette City Council amending the Lafayette Development Code so as to reclassify the property of Case No. 2026-1-AZON Hobson Street and North Buchanan Street Administrative Rezoning, located generally north of Mudd Avenue, west of North Buchanan Street, and south of North Buchanan Street; 311, 313 & 315 (on one lot), 319, 401, 405 & 407 North Buchanan Street, 100, 101, 102, 106 & 107 Hobson Street, and 101, 103 & 107 Mudd Avenue being rezoned from IL (Industrial-Light) to MN-2 (Mixed-Use Neighborhood). [CO-039-2026](#) An ordinance of the Lafayette City Council amending the Lafayette Development Code and the official map of the City of Lafayette, providing for the annexation of additional land into the Corporate Limits of the City of Lafayette, Louisiana, Case No. 2026-6-REZ 300 Block Tolson Road Annexation (Lots 1-5), located generally north of Hamilton Parc Way, east of Tolson Road, and south of Terville Avenue; and assigning a zoning classification of CM-1 (Commercial Mixed) (District 4). (CD&P)

[CO-040-2026](#) An ordinance of the Lafayette City Council approving a Conditional Use Permit to allow a dwelling, two-family (duplex) in a RS-1 (Residential Single-Family) zoning district, Case No. 2026-7-REZ 100 Wilkins Street CUP (Conditional Use Permit), located generally north of Markham Street, east of Liston Street, and south of Hammond Road. (CD&P)

[CO-041-2026](#) An ordinance of the Lafayette City Council amending the Lafayette Development Code and the official map of the City of Lafayette, providing for the annexation of additional land into the corporate limits of the City of Lafayette, Louisiana, Case No. 2026-8-REZ 100 Block Darbonne Road Annexation, located generally north of Woodbridge Drive, east of Tolson Road, and south of Darbonne Road; and assigning a zoning classification of RM-1 (Residential Mixed) (District 4).
